The second phase begins when drivers accept a ride request and are en route to pick up passengers, triggering higher coverage limits. The third phase, with passengers in the vehicle, provides the most comprehensive coverage.

This tiered system often leads to disputes between personal auto insurers and rideshare company policies, leaving accident victims caught in the middle. Common injuries sustained in rideshare accidents include whiplash, traumatic brain injuries, broken bones, and soft tissue damage, all requiring substantial medical treatment and potentially resulting in lost wages.

The legal complexities extend beyond insurance coverage. Determining liability in rideshare accidents requires examining multiple factors, including driver employment status, vehicle maintenance records, and the specific circumstances surrounding the collision. Additionally, rideshare companies typically classify drivers as independent contractors rather than employees, adding another layer of complexity to legal proceedings.

"We've developed specific strategies to handle the unique aspects of rideshare accident cases," noted Ross Moore. "Our approach includes thorough investigation of all available insurance policies, careful documentation of the driver's app status at the time of the accident, and aggressive negotiation with multiple insurance carriers to maximize our clients' recovery."
