



## **Siam Legal Chiang Mai Addresses DTV Visa Considerations as Forbes Names City Top Digital Nomad Destination**

Siam Legal Chiang Mai is advising foreign professionals and remote workers to review their visa and legal position following Forbes' recognition of Chiang Mai as one of the world's eight leading destinations for digital nomads and creators in 2026.

The international publication listed Chiang Mai alongside Medellín, Cape Town, Lisbon, Bali, Mexico City, Tokyo, and Berlin in its assessment of top locations for remote professionals and digital entrepreneurs. The recognition reflects Chiang Mai's development into a destination that foreign professionals now evaluate on the strength of its business infrastructure, professional networking environment, and income-generation potential, not only on cost of living and climate.

Siam Legal Chiang Mai notes that the city's appeal extends beyond traditional digital nomadism. Forbes' report highlights how digital entrepreneurs increasingly seek locations that support serious professional

activity. Chiang Mai's coworking infrastructure, particularly in neighborhoods such as Nimman and the Old City, its established expatriate business community, and its growing profile as a meetings and conference destination have contributed to this shift, alongside the city's Lanna heritage, craftsmanship traditions, and festival culture that make it a distinctive long-term base for creative professionals.

"Chiang Mai's recognition as a leading destination for digital nomads and creators reflects how the city has grown into a serious international hub for professionals, entrepreneurs, and creative industries," said Apichart Mattayanuwat, Attorney at Law at Siam Legal Chiang Mai. "For eligible remote workers and digital entrepreneurs, the Destination Thailand Visa may offer a useful long-stay pathway, but applicants should carefully review their category, documentation, and legal position before making Chiang Mai their long-term base."

The Destination Thailand Visa, or DTV, offers a 5-year multiple-entry visa allowing stays of up to 180 days per entry. Eligible applicants may apply under the Workation category or Soft Power activities, depending on their circumstances. The application must be submitted at a Royal Thai Embassy or Consulate outside Thailand through the Thai eVisa portal online. Applications cannot be submitted from inside Thailand. For Chiang Mai-based applicants, the Royal Thai Embassy in Vientiane, Laos is the most commonly used nearby post, with processing times that are typically faster than applying through embassies in Western countries. The Thai Embassy in Penang, Malaysia is another established option frequently used by applicants based in northern Thailand.

Siam Legal Chiang Mai advises applicants to prepare comprehensive supporting documentation, including proof of remote work or freelance contracts, business ownership documents, professional portfolios, bank statements, and clear explanations of their intended activities in Thailand. The firm emphasizes that remote work, freelance activity, and long-term stays each require proper visa eligibility review and documentation preparation before an application is submitted.

As more remote professionals establish an extended presence in Chiang Mai, legal considerations become increasingly relevant. Siam Legal Chiang Mai notes that DTV holders are not authorized to work for Thai employers, open Thai businesses, or hire local staff. The visa covers remote work for foreign clients and employers only, and operating outside those boundaries creates immediate legal exposure. The firm recommends that long-stay residents review lease agreements before signing and assess their tax position under Thailand's foreign income remittance rules. Those with existing or planned business interests in Thailand should seek separate legal advice, as the DTV does not provide a pathway to Thai business activity.
